If a vehicle connected to a crafter is in a bus zone, even temporarily, you will not be allowed at future Bar Harbor fairs, as you are risking our organization's ability to host craft fairs in Bar Harbor. By submitting this application, you are acknowledging that you have read & agree to this policy.

# Island Arts Association Rules & Code of Conduct

---

## **RULES:**

### **Tents, set up and parking:**

1. Set up and tear down are to be done during designated hours only. You must arrive no later than one hour before the start of the fair and be set up by the start time. You may not break down early during a fair. Inclement weather decisions will be made as needed.
2. Canopies with tablecloths are required. No stakes are allowed in the ground. Adequate weights must be used. We do not provide canopies. Sides are recommended to zip down at night or in inclement weather.
3. No electricity is available, and no generators are allowed.
4. After unloading your vehicle, move it to the designated parking area.
5. Keep your set up within your 10 x 10 space assigned.
6. Outdoor fairs may involve uneven ground (particularly on the Village Green). It is your responsibility to bring the necessary supplies to be adaptable to your assigned space.
7. Security is provided for all 2 day fairs. We do not recommend leaving your products in your tent. The IAA assumes no responsibility for theft or damage of any kind.

### **Miscellaneous Rules:**

1. No mass-produced items allowed. ALL items must be made by you and your partner, if applicable. Photography can be sold as printed items.
2. NO alcohol may be consumed at the fair. No sales of tobacco or drug paraphernalia.
3. No small children or pets are allowed.
4. Please respect Board Members, and abide by their directions.

## **CODE OF CONDUCT:**

1. All crafters are to conduct themselves in a professional manner to include: no foul language, no discussion of politics with customers, no questions regarding customer COVID vaccinations, etc. We are a community that supports each other.
2. Keep your voice volume to a level that does not disturb your fellow crafters.
3. Do not share your personal finances per fair with your fellow crafters. That is personal information and should remain that way.
4. Support each other by helping others in need to set up and break down.
5. If you have more than one crafter in your booth, offer the singular crafter a chance to take a comfort break.
6. Treat others as you would like to be treated.

## **JURYING:**

All IAA fairs are juried. If you are a new crafter to our fairs or you have not participated in at least two fairs within the past year, we ask that you provide our board with images or your work that will be featured at our craft fairs. These images can be provided via the following methods:

- Provide a link to your website, Etsy shop or Business page on Facebook.

## **PAYMENT:**

- Separate checks are required for each fair you are applying for. You may mail multiple applications in the same envelope, however each fair must have separate checks.
- If accepted to the fair, we will deposit the check upon acceptance to the event.
- If not accepted to the fair, your check will be mailed back to you.
- If you are placed on the wait list for a fair, we will hold your check until the week of the event. If no space becomes available, we will notify you and mail your check back to you. If a space becomes available, we will notify you and deposit your check.
- A fee of \$35.00 NON-SUFFICIENT FUNDS fee will be assessed for all checks that do not clear your bank and you will NOT be allowed to participate in the fair.

## **CANCELLATION:**

- NO CANCELLATIONS OR RAIN DATES! Application fees are non-refundable.
- If a full fair is canceled due to forces beyond the IAA's control, fees will be returned.
